Release of Liability and Indemnity Agreement for Owners

I, _____, having been advised and fully informed by the Windsor/Essex County Humane Society concerning the nature and purpose of the “Happy Tails Dog Park” and am aware of certain risks associated with exercising dogs in a fenced-in dog park where other dogs are being exercised. On behalf of myself, my estate, my heirs, successors and assigns, I do hereby release the Windsor/Essex County Humane Society, its members, officers, volunteers, employees and agents from any claims or liability for death, injury or damages, whether to person or animal related to the use of the premises, and further, I agree to hold harmless the Windsor/Essex County Humane Society its members, officers, volunteers, employees and agents, from all liability involved in the use of the “dog park”. I understand and recognize that numerous dogs, including those in the care of the Windsor/Essex County Humane Society, use the dog park and that the premises include open ground that is used by other animals, both domesticated and undomesticated (wild), and therefore understand that I and my pet may be at risk of the condition of the premises and failure of other users to control their pets.
